Street Closure and Barricades (see conditions of closures on next page)

The City of Arroyo Grande does not provide barricades for block parties. Items used must be easily and immediately moveable to allow emergency vehicle access but still reasonable ensure the safety of block party participants in the street. At the applicants's request, the Police Department can provide guidance in determining the most appropriate barricades; however, the applicant shall be responsible for any civil liability incurred in the choice of vehicular traffic barricades. The Arroyo Grande Police Department recommends the use of water-filled K-rails for barricades and provide contact information for a barricade vendor.

Conditions of Closure

Applicant(s) is/are responsible for providing and removing barricades/barriers and warning signs used to safely close the affected area. Half of the width of the public roadway/street for the entire length of the closure of the affected area must remain clear of obstacles/objects, e.g. tables or barbecues, to accommodate emergency vehicle access and egress in the event of an emergency. Applicant(s) must collect and remove all trash, garbage and litter caused by or arising from the area closure. Event activities shall not create a public or private nuisance or an undo hazard or disturbance to the public peace, tranquility, health, welfare, safety or morals as defined by applicable sections of the Arroyo Grande Municipal Code, nor create an excessive burden on police, fire, other emergency services or other public operations equipment, personnel or facilities, e.g. the Public Works Department. Block party permits do not waive compliance with the Arroyo Grande Municipal Code Ordinance regarding noise in Chapter 9.16. Block party permits will not normally be authorized for times of darkness without the use of appropriate Police Department approved reflective materials to be used in conjunction with barricades. As per Chapter 9.04.020 of the Arroyo Grande Municipal Code, alcoholic beverages shall not be consumed or possessed with the intent to consume in any public place, e.g. a public roadway or sidewalk, not licensed for the consumption of alcoholic beverages. Alcoholic beverages shall not be sold in conjunction with the event without authorization/temporary licensing by the California State Alcoholic Beverage Control Commission.

The Arroyo Grande Police Department reserves the right to immediately revoke a block party permit for reasons including, but not limited to, violations of the conditions of the permit or conditions that reasonably endanger public health or safety. Refund of permit fees will not be provided if a block party permit is revoked for any reason.

Acknowledgement

As applicant(s) for the proposed block party permit, I/we certify that a majority of owners, residents or tenants of the properties fronting the affected area have consented to the closure. I/we also certify that I/we have reviewed the "Conditions of Closure" and the definition of a Temporary Street Closure and understand the restrictions that are applicable. I/we are also aware that the block party permit can be immediately revoked if California Penal Code Section 415 (disturbing the peace), Arroyo Grande Municipal Code Chapters 9.04 (alcoholic beverages) or 9.167 (noise ordinance) or any other applicable Penal Code or Municipal Code sections are violated.
